Preview User Interface Access

Preview data will be available to eligible hospitals and critical access hospitals participating in the Medicare Promoting Interoperability Program via the CMS Hospital Quality Reporting (HQR) system page at <https://hqr.cms.gov/hqrng/login> from **August 20–September 18, 2026**.

Access Preview Data

1. Navigate to the HQR system page: <https://hqr.cms.gov/hqrng/login>
2. Enter your Health Care Quality Information Systems Access Roles and Profile (HARP) User ID and Password. By logging in, you agree to the terms and conditions. Then, select **Log In**.
3. You will see the **Two-Factor Authorization page**. Select **Text** or **Email**. Then, select **Next**.
4. Enter the code you received and select **Next**.
5. On the **HQR** system landing page, hover over *Lock Menu* on the left side.
6. Select **Program Reporting**.
7. From the drop-down menu, select **Public Reporting**.
8. The page will refresh, and the data will be available to preview.

Preview Content
